

## Mallorca bike hire 2026

Bicycles are provided by Wheels Sport – they have quality road bikes available for hire, as outlined below. Please note that all bikes are set up with European braking (i.e. rear brake on right)

Mellow Jersey will reserve this on your behalf, but the hire contract is between yourself as the client and Wheels Sport directly (see later in this document for terms and conditions). Please note that availability in some sizes is limited, so we suggest booking your bike as early as possible.

**Payment for bike upgrades (if applicable) will be added to your final tour balance.**

**We recommend that take note of any damages and take photos accordingly, as you are responsible for any damage or loss that may occur during the rental period. The hire includes insurance that covers damage in the case of an accident, but does not cover theft.**

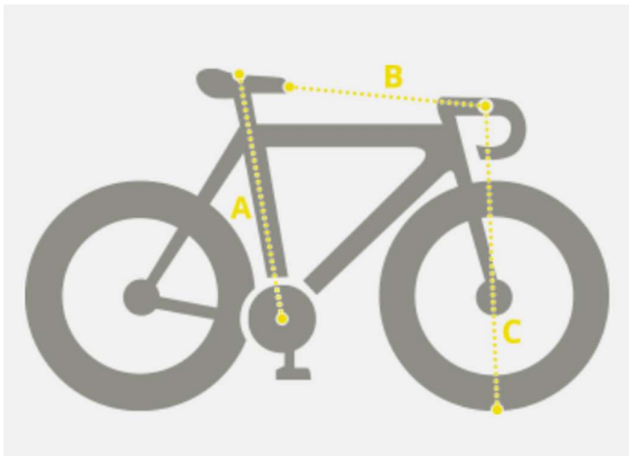
**We recommend you bring your own saddle, which we will help fit onto the hire bike.**

Below is a list of the bicycles available for hire. To reserve your bike, please provide us with the following information so we can reserve this on your behalf with the shop (Pricing based on 5 night tour, additional days hire will be charged accordingly for the 7 night package)–

- Name
- Bike model
  - Road Carbon Disc Di2 105 – included in package
  - Road Carbon Disc Di2 Ultegra- £80 supplement
- Your height in cm
- A/B/C measurements in cm (instructions included below)
- Pedals required (£5 if required) – Look keo, Shimano SPD, Shimano SPD SL, or bring own?
- Helmet required (included in hire cost) or bring own?

All bikes come with a spare inner tube, tyre levers and bottle cages.

## Terms and conditions

### 1 Contracting parties and Duration of the contract

#### 1.1 Contracting parties

The contracting parties are the person, who rents ("arrendatario" as following, translated lessee) and Wheels Sport S.L. C/Nicolau Riera Marsa nº2, B-07614498 Pto. Alcudia ("arrendador" as following, translated lessor). It forms the contract between "the lessee" and "the lessor", which means the agreement between these two parties. "The lessor" is obliged to provide a bicycle to "the lessee", which is in conditions of use and secure according to the road safety. "The lessee" is obliged to pay in advance the total price of the rent at the moment the contract is formed.

#### 1.2 Duration of the contract and Breach of return

The contract of the bicycle has an established period of time and this has to be respected. In case of breaching this signed period of time Wheels Sport S.L. will use its right to impose a compensation. In case, that this action has an impact to another client's reservation, the compensation might raise up to 600€.

#### 1.3 In Advance return

If "the lessee" returns the bicycle before the end of the contract, which was agreed, there is no right to reimburse the corresponding partial of non-consumed period.

### 2 Use and return of the bicycle / Notice of damage and other obligations

#### 2.1 State of the bicycle and Incorrect use

"The lessor" hands the bicycle in to "the lessee" in a good state of use suitable according to the road safety, as well as clean. "The lessee" confirms his knowledge of the bicycle's functions and is familiar with the technical devices of the bicycle. "The lessee" will be obliged to use the bicycle in a careful way and technically correctly, which means following the rules of road safety and circulations. It is prohibited the use of the bicycle under effects of drugs and / or alcohol. It is also prohibited to make any kinds of modifications or alterations to the bicycle without any previous consent.

#### 2.2 Obligatory notifications

If there is any damage done during the use of the bicycle without any importance that it is or it is not "lessee's" fault, he will have to report to "the lessor" about the damage caused. In case, that the damage leaves the bicycle in an unsuitable condition and / or it is broken with "the lessee" being uninvolved, "the lessor" changes the bicycle or finds another solution to make "the lessee" continue.

#### 2.3 Changes

If you want to change the bicycle at the moment of pick-up, "the lessor" could make a change, if there is the same size or the same model available. If the bicycle is changed for a superior price one, the price difference has to be paid at the moment of the change. If the bicycle is changed for an inferior price one, there is no right for any reimbursement or redaim.

#### 2.4 Obligation of notification in case of theft or accident

In case of a theft or a traffic accident "the lessee" is obliged to report it or ask for an immediate police attendance, as well as report it to "the lessor". "The lessee" will be responsible prior to "the lessor" for the damage and defects caused by breach of the previous obligations.

#### 2.5 Return

"The lessee" will be obliged to return the bicycle at the date and the hour written in the contract in the same state, which the bicycle was given to him, apart from any common dirt. The bicycle return has to be done on the last day of the rent in the rental shop Wheels Sport S.L., that was stated in the contract and according to the business hours. The return to any other rental shops of Wheels Sport S.L. is possible only due to prior communication in written form. The bicycle wash-up is included in the rental price. During the bicycle return the contract between the two parties has to be shown.

### 3. Responsibility of the "lessee" for the damage and loss

#### 3.1 General responsibility of the "lessee"

"The lessee" will be responsible for all personal and material damage, as well as those, that will be derived from the accident(s) and civil responsibility, which means the damage like negligence, severe negligence or deliberate negligence. "The lessee" will be responsible prior to "the lessor" for the damage, loss or breach during the whole period of the rent. It will be "the lessee's" responsibility to pay the total amount indicated, according to the current pricelist calculations of "the lessor". The rental price paid by "the lessee" will be subtracted from this amount. In case of any damage and / or defects based on the illicit intention acts or severe negligence "the lessee" will be responsible for the expenses of the repair and the spare parts.

#### 3.2 Theft responsibility

"The lessee" will also be responsible prior to "the lessor" for the theft or any other loss of the bicycle. In case of the theft "the lessee" will be responsible for the total amount of the price of the bicycle according to the current pricelist calculations of "the lessor". The rental price paid by "the lessee" will be subtracted from this amount.

#### 3.3 Reimbursement of the total amount

If the bicycle is found later on "the lessor" will reimburse the total amount paid to "the lessee", always in case, that the bicycle will be in the suitable state of possible re-renting and as a fair gesture of quality. He will inform "the lessee" how and how much will the reimbursement be paid.

#### 3.4 Exclusion of responsibility of "the lessee" (Insurance)

Redamations of "the lessor" of the damage caused by an accident can be excluded for an additional fee paid by "the lessee". The fee is based on the model of the bicycle and will be paid immediately when the contract is formed. The right of reclamation of the damage caused by an accident will only be excluded, if the damage caused by the accident is not found as a deliberate or severe negligence of "the lessee".

#### 3.5 Additional equipment

All bicycles are equipped with a computer, a small pump and a bag, that holds one spare inner tube and two levers. These extras are not included in the insurance and the missing parts have to be paid by "the lessee" according to the current pricelist of "the lessor".

### 4. Cancellation of the reservation

1. If you have a valid reservation and you want to cancel it, you have to contact us via e-mail at [info@wheelssport.net](mailto:info@wheelssport.net)
2. If you contact us regarding the cancellation at least 30 days before the pick-up date, we will return you the total amount of your reservation subtracting the corresponding management fees, which will be 10€.
3. If the notification of the cancellation is done between 15 and 29 days before the pick-up date, we will return you 50% of the total amount of your reservation subtracting the corresponding management fees, which will be 5€.
4. If the cancellation of your reservation is done within the last 14 days before the pick-up date, there is no right for any payback.
5. The cancellations due to weather conditions are not accepted in any case.
6. If you are aware of any pick-up delay, please let us know immediately, otherwise your reservation will be cancelled within the next 24 hours.

### 5. General clauses and Applicable legislation

#### 5.1 Written conditions

The contract will be a subject to the written conditions. Any modification or amendment of an agreement done has to be written down, as well. Any additional spoken agreements are not allowed and are strictly prohibited.

#### 5.2 Applicable Law and Jurisdiction

The regulations of the contract are subdue to the Spanish legislation. Any controversy, which might emerge in the interpretation of the contract will always be subdue to the jurisdiction of the Municipal Court in Inca, Mallorca.
